**THE TECHNICAL ARRANGEMENT BETWEEN THE GENERAL
INSPECTORATE OF CARABINEERS OF THE MINISTRY OF INTERNAL
AFFAIRS OF REPUBLIC OF MOLDOVA (MD) AND THE ARMA DEI
CARABINIERI OF ITALY (IT)**

Preamble

The General Inspectorate of Carabineers of the Ministry of Internal Affairs of the Republic of Moldova, hereinafter referred to as the “Receiving Party” and the Arma dei Carabinieri of Italy, hereinafter referred to as the “Transferring Party” and;

taking into account

the Agreement between the Government of the Italian Republic and the Government of the Republic of Moldova on Defense Co-operation, done at Rome on the 6th December 2006

in view of

the Technical Arrangement for joint cooperation between the Department of Carabineers Troops and Arma dei Carabinieri from Italian, signed on the 3rd October 2016;

considering

that this Technical Arrangement will enhance the relations between the Italian Republic and the Republic of Moldova, with specific regard to the field of Defense;

wishing

to reach an arrangement to define the details regarding the transfer of goods and materials (free of charge, as a donation),

have decided as follows:

ARTICLE 1

PURPOSE

This Technical Arrangement between the General Inspectorate of Carabineers of the Ministry of Internal Affairs of the Republic of Moldova, hereinafter referred to as “Arrangement” and the Arma dei Carabinieri of Italy, aims to define the details regarding the conveyance and final transfer, free of charge, as a donation, of two canine units (female).

ARTICLE 2

OBJECT OF THE DONATION

The goods and materials that constitute the object of the donation are specified in the Annex to this Arrangement. The Annex is an integral part of this Arrangement.

ARTICLE 3

TRANSFER OF GOODS AND MATERIALS

The two canine units (female), that constitute the object of the donation, will be transported from Italy to Moldova, free of charge, by and at the expense of the "Transferring Party".

ARTICLE 4

DELIVERY OF GOODS AND MATERIALS

1. The delivery of two canine units (female) will take place at the time and place chosen by the Parties and will be performed by Representatives specifically appointed by the Parties themselves.
2. The Receiving Party will sign a specific receipt as proof of delivery of two canine units (female) in the conditions agreed upon. Starting from the date of the signature of the above-mentioned receipt, the ownership transfer of goods and materials will be considered concluded.

ARTICLE 5

DESTINATION OF GOODS AND MATERIALS

1. The Receiving Party will employ and preserve the two canine units taking all forms of caution for the health and care of animals.
2. Furthermore, the Receiving Party will not sell the goods and materials received and will not transfer them to a Third Party under any circumstance without having been previously authorized to do so by the relevant Italian authorities.

ARTICLE 6

SETTLEMENT OF DISPUTES

Any dispute regarding the interpretation or application of this Arrangement shall be resolved through direct consultation between the Parties.

ARTICLE 7

DURATION OF THE ARRANGEMENT

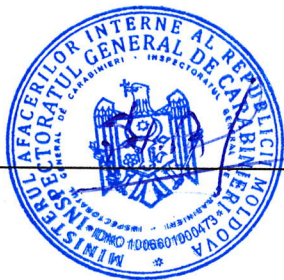
1. This Arrangement will come into effect on the date of signature.

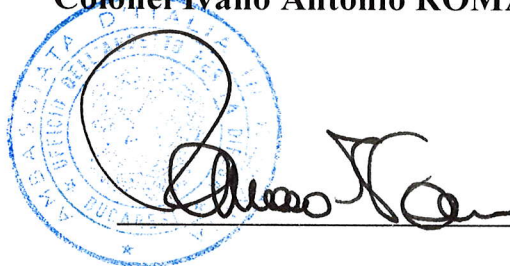
